- a) The undersigned Author(s) hereby assigns, conveys, and otherwise transfers all rights, title, interest, and copyright ownership of said work for Publication;
- b) The Author(s) grants exclusive rights to IYRES PUBLISHER the worldwide, royalty-free, exclusive right to first publish the Contribution and the Author(s) agrees not to publish or authorize any third party to publish the Contribution in any (language), media or format, except as mutually agreed between the parties at later stage;
- c) All accepted works become the property of the Publication and may not be published elsewhere without prior written permission from IYRES PUBLISHER.
